Mandatory Compliance Conditions

1. **Supply Chain Disclosure** Prior to the issuance of any Halal Certificate, applicant companies must submit a formal declaration and a comprehensive list of all organizations and entities to which their Halal-certified products are supplied.
2. **Export-Only Restriction (Uttar Pradesh)** The applicant declares that Halal Certification is sought exclusively for export to international markets.

The applicant strictly agrees to the following:

- **No Domestic Display in UP:** The Halal Certificate shall not be displayed in offices, factories, retail outlets, or any public space within Uttar Pradesh.
- **Packaging Restrictions:** The Halal Logo shall not be used on product packaging, outer casing, or marketing materials visible within Uttar Pradesh.
- **International Use Only:** End products bearing the Halal Logo are restricted strictly for sale and distribution in international markets.

Global Assurance – Al-Qalb Global Halal Certification Pvt. Ltd. reaffirms that these restrictions are **local to Uttar Pradesh**. Across the rest of India and worldwide, Halal Certification and logo usage remain fully valid and unrestricted, in line with international standards and practices.
